**Market Pick-ups**

Our farm fresh produce and add-ons will be made available Friday evenings at the Gifford Park Neighborhood Market, which is located at 520 N. 33rd Street, Omaha, Nebraska, 68131. Our season will likely begin in mid-May and conclude in mid-October. **Pick-ups will be during market hours, 5:00pm to 7:30pm.** You will also have to opportunity to shop from other local vendors and support the local economy!

We will also offer on-farm “harvest pickups” on **Tuesday evenings from 4:00pm to 6:00pm**, at our farm plot located at 33rd and California Streets. These pickups will be offered in the early spring season and pick back up again late summer and fall, due to seasonality of the crops grown at this site.

**Remaining balances**

You are responsible for using your farm balance throughout the season. Each time you use your farm credit at our market stand, we will deduct your payment from your account and inform you of your up-to-date balance. As the season comes to a close, we will remind you of any remaining balance and give notice when the season is coming to a close. The nature of a CSA is to build a relationship between members and producers, where the member invests in the beginning of the season and the producer provides throughout the season. As such, we will not be able to provide reimbursements of unspent balances, after the final market of the season. Thank you for your understanding!

**Risk sharing**

Joining a CSA means you are willing to share the risk of inclement Nebraska weather with us as well as support small, local-growers, eat seasonally, and form relationships with the people growing your food. In the event that crops are damaged, Big Muddy Urban Farm will do our best to provide you with the quantities and varieties we have available.
